- 1. The Commencement Committee has been researching what other colleges are doing for commencement, as it is not likely Commencement will be held on May 16th. They are looking for ideas for a virtual commencement or other way to celebrate graduating students.
- 2. They are thinking of having a virtual, asynchronous celebration in August. One possibility could have it on a website such as President Lane's remarks, recognition of grads, and many other parts. The other possibility is that each graduate could receive a celebration package (cap, diploma, gift from alumni, etc.).
- 3. President Lane is thinking of allowing 2020 grads to walk at the 2021 Commencement.
- 4. Students who participate in graduation pay for their cap and gowns.
- 5. She would like to come back and talk to SGA with more information about budgeting and ideas of what to put in the packages.

- 1. Sheila suggests sending an announcement on Navigate to graduating students and encourage them to join an SGA open forum to discuss their opinions on Commencement and graduation. She would like to see caps and gowns in the celebration boxes instead of just caps so that students can take pictures with them and have them.
- 2. The All College Assembly has been cancelled for right now.

Open Forum

- 1. It was discussed that caps and gowns should not be part of the surprise package, as students will need to inform the college of their specific gown and cap size.
- 2. Courtney asked the Executive Committee about whether NECC will follow the pass/fail method that other colleges are doing. Sheila believes Bill Heineman is steering away from pass/fail due to underlying reasons. Bill Heineman has asked staff to take into consideration to be more lenient with grading and deadlines as students are struggling with financial burdens, loss of jobs, etc.
- 3. Students who are having issues with strict professors can contact the chairs or deans of the academic areas.
- 4. Returning students who are in good standing with the college will be able to register themselves for classes through Navigate.
- 5. There is still discussion about whether to run summer classes as only online, but there has not been any final decisions about cancelling classes.
- 6. Classes will still end on May 11th, but the withdrawal and registration dates have been updated.

Tabled Business

- 1. Elections Timeline
 - a. SGA needs to rework this timeline and discuss as a group how to move forward with this.
 - b. Students will fill out an interest form with their name and student ID, they will then receive a virtual petition and need to get 50 virtual signatures, and will be added to the ballot.
 - c. Samantha thinks it would be helpful to outline ways for students to contact their fellow classmates as well as solidifying all of the dates.
 - d. Stephanie and Rosielis will be meeting together to discuss a final timeline and other information that will be sent to students.
- 2. OER Campaign
 - a. Stephanie created an OER Campaign Google Doc form. SGA will be promoting OER resources on social media, but are still waiting to hear back from Susan Tashijan.
- 3. Blackboard Page
 - a. Courtney has not heard back from the faculty about finalizing the page. She will be reaching out and letting them know we want the page to be public to all students.
 - b. Stephanie was having issues updating the SGA website, so she reached out to the necessary faculty members and asked for help in fine tuning the updates and fixing some errors.

Trustee Report

- 1. It was voted that the class fee increase of \$6 per credit and the facility fee was increased by \$20, which will be instituted in the Fall 2020 semester. However, there is talk that these amounts are preliminary and will be discussed further in the summer. Additionally, these are the same amount that it was increased last year.
- 2. Sheila noted that the CARES Act was approved, so community colleges may be getting more funding due to the current situation. NECC will be getting an undetermined portion of that. Since NECC has lost some revenue due to COVID-19, so the fees may increase.
