CATEGORY C: REQUIRED TO REGISTER BUT DID NOT REGISTER

I AM A MALE U.S. CITIZEN OR ELIGIBLE NON-CITIZEN, OVER 26 YEARS OF AGE, AND BORN AFTER DECEMBER 31, 1959, WHO NEVER REGISTERED WITH SELECTIVE SERVICE.

- ☐ **Contact Selective Service to obtain a Status Information Letter.** Go to www.sss.gov to download the request form, or call (847) 688-6888.
- ☐ **Write a typed, signed personal statement explaining why you did not register.** This statement must provide a complete description about your situation including but not limited to: where you were living during the period when you should have registered, whether you were unable to register due to incarceration or hospitalization, and your citizenship status during the time you were required to register, etc.
- ☐ **Send a copy of the Status Letter, your personal statement, and the signed and dated form to the Financial Aid Office.**
